In this book the author employs a series of supervised and unsupervised techniques used in non-traditional Authorship Attribution-applied here for the first time in ancient drama. The outcome of the analysis indicates a significant distance between the disputed text and the secure plays of Aeschylus, but also various interesting (micro-linguistic) ties of affinity with other authors, especially Sophocles and Euripides.
